## SCHEDULE "A"

### TERMS AND CONDITIONS

#### APPLICABILITY:

This standard applies to all **Class H- Mosquito Control** pesticide applications operating in New Brunswick and may be cited as the "Sector Standard for Aerial Pesticide Control in New Brunswick".

#### A. DEFINITIONS

**"Animal"** includes a bird, reptile, amphibian, fish, invertebrate, or mammal other than a human.

**"Applicator Certificate"** means a certificate issued by the New Brunswick Department of Environment and Local Government to an individual recognizing that the individual has received the appropriate education and training to ensure that the application of pesticides is conducted responsibly and safely.

**"Department"** means the New Brunswick Department of Environment and Local Government.

**"Environmental Emergency"** means a spill or loss of pesticide greater than two hundred litres (200 L) of pesticide mix, or twenty litres (20 L) of concentrated pesticide, or any quantity which may cause injury or damage to the natural environment, to *animal* or plant life. An environmental emergency also includes any situation where there has been or will be a release, discharge, or deposit of a contaminant or contaminants to the atmosphere, soil, surface water, and/or groundwater environments of such a magnitude or duration that it could cause significant harm to the environment or put the health of the public at risk.

**"Habitation"** means a structure (camp, cottage, house, etc.) adapted for occupation by any person or persons.

**"Inspector"** means an Inspector designated under the New Brunswick Pesticide Control Act.

**"Permit Holder"** means the person or entity to which the permit is issued, as named on the front page of this Pesticide Permit.

**"Public Area"** means any area to which the general public has access.

## **B. GENERAL**

1. This Pesticide Permit does not relieve the *Permit Holder* from compliance with other bylaws, federal or provincial acts or regulations, or any guidelines or directives pursuant to regulations.

## **C. EMERGENCY REPORTING**

2. During an *Environmental Emergency* situation, the *Permit Holder* shall ensure:
  - (a) **Immediately** following the discovery of the *Environmental Emergency*, a designate representing the *Permit Holder* shall immediately contact the **Regional Emergency Center** by telephone at **1-800-565-1633**.
  - (b) Within one (1) day of the time of initial notification, a copy of a **Detailed Emergency Report** shall be sent by a designate representing the *Permit Holder* to the *Department*. The Detailed Emergency Report shall include, as a minimum, the following: i) a description of the problem that occurred; ii) a description of the impact that occurred; iii) a description of what was done to minimize the impact; and iv) a description of what was done to prevent recurrence of the problem.

## **D. CERTIFICATION**

3. The *Permit Holder* shall ensure that all individuals directly involved in the application, handling, loading, mixing, storing, or transportation of pesticides hold a valid *Pesticide Applicator Certificate* with the appropriate classification based on the class of pesticide application listed on the front page of this Pesticide Permit.
4. The *Permit Holder* shall ensure that all certified pesticide applicators keep their *Pesticide Applicator Certificate* in their immediate possession when handling, loading, mixing, storing, transporting, and applying pesticides.
5. The *Permit Holder* shall ensure that all personnel directly involved in the ground mosquito larval control supervision of pesticides hold a valid **Class H** pesticide applicator certificate.

#### E. AUTHORIZED PRODUCT

6. The *Permit Holder* shall ensure that only the following pesticides are used when conducting any pesticide application:

PCP No.	Pesticide Trade Name
18158	Vectobac 200G
21062	Vectobac 1200L
26863	Aquabac 200G

The *Permit Holder* shall ensure that if any additional pest control products are to be used, an amendment to this Pesticide Permit is obtained from the *Department*. All pesticide applications must be conducted under the more restrictive requirements of product labels or of this Pesticide Permit's terms and conditions.

#### F. BUFFERS / SETBACKS

7. The *Permit Holder* shall ensure that no mixing and loading of pesticides takes place within thirty metres (30 m) of surface water. Should a product label specify a greater aquatic setback then the label setbacks must be maintained.

#### G. NOTIFICATION

8. The *Permit Holder* shall ensure that the *Department* is notified in writing **48 hours** prior to the commencement of the pesticide application.
9. The *Permit Holder* shall ensure that the local Fire Department and local office of the Department of Public Safety are notified as to the location of all pesticide storage facilities for which the *Permit Holder* is responsible, and must also supply a copy of the *Permit Holder's* Contingency Plan.

#### H. STORAGE

10. A copy of the *Permit Holder's* permit and Contingency Plan, along with appropriate pesticide product labels and applicable Material Safety Data Sheets (MSDS), must be available at all pesticide storage areas and in all vehicles carrying pesticides.

## **I. VEHICLES**

11. The *Permit Holder* shall ensure that transported concentrated pesticides are contained in a secure area, or compartment that is not accessible to unauthorized individuals.
12. The *Permit Holder* shall ensure that a quantity of approved absorbent material will be on hand at all times in case of a spill. The vehicle shall carry clean-up equipment including but not limited to, absorbent material, shovels, brooms, bags, buckets, or pails.

## **J. RECORD KEEPING**

13. The *Permit Holder* shall ensure that records are kept pertaining to the following information:
  - (a) a record of each property that was treated (address, property description, etc);
  - (b) the date and time of the application;
  - (c) the specific type of pest that was being targeted; and
  - (d) the quantity of pesticides that were used in the treatment.

## **K. REPORTING**

14. By **February 1<sup>st</sup>**, the *Permit Holder* shall submit a Pesticide Usage Form to the *Department*, containing the total quantity (in kilograms or litres) of each pest control product used, for the previous calendar year.
